Program Overview

This unique educational opportunity – delivered through a partnership between the Tulo Centre of Indigenous Economics (Tulo), Thompson Rivers University (TRU) and the First Nations Tax Commission (FNTC) – has been developed to build skill set for First Nation staff.

First Nations are endeavoring to develop their economic infrastructure. The Certificate in First Nation Applied Economics (CFNAE) program provides key foundational skills and knowledge for building indigenous economic infrastructure. The knowledge and skills acquired through this program will produce human capital that will yield long-term benefits in terms of developing residential and commercial enterprises on First Nation lands.

After an introduction to basic microeconomics and macroeconomic principles, students are exposed to First Nation issues as they relate to market failure and poverty. Knowledge is developed to facilitate the reduction of transaction costs of doing business on First Nation lands in order to promote and facilitate investment activity. Specifically, the program focuses on residential and commercial development on First Nation lands. Furthermore, the program provides basic skills for conducting and understanding cost-benefit analysis, as well as writing and presenting reports for investment proposals.

Program Approach

The CFNAE is designed to transfer skills, knowledge and best practices to First Nations who currently are, about to be, or are interested in, how markets work on Indigenous lands. The program is available in a face-to-face (F2F) setting and is designed to help participants develop an understanding of, and the skill set required to manage, economic development projects.

This program, developed and taught by industry leaders, includes real life case studies, relevant multimedia presentations and state of the art activity-based learning. Students are taught with quality, real-world information, and are given opportunities to practice what they have learned in the classroom setting. This approach is intended to impart practical knowledge, skills and confidence, ensuring that students acquire core knowledge and skills needed to implement and run economic development projects.

WHO SHOULD TAKE THIS PROGRAM

This certificate comprises of eight courses that provide a general understanding of the issues in First Nation economics. It is intended for First Nation administrators, persons working for First Nations in economic development and/or property taxation, persons interested in the field, persons working for firms desiring to do business on First Nation lands, and persons working for other governments with an interest or requirement to work with First Nation economic development projects.

Participants must be have computer skills and be knowledgeable about the Internet, using email and web browsers, and be conversant with computer technology in general. Program participants must also have written and oral fluency in the English language before entering the program.

Benefits

TO THE PARTICIPANTS

This certificate provides many personal benefits, including:

- career prospects and advancement;
- personal and professional development;
- flexible schedule and delivery;
- ability to continue working while earning a CFNAE certificate;
- small class sizes;
- networking with other students and developing important professional connections; and

This certificate provides many community benefits, including:

- maximizing benefits from FMA legislation;
- capacity to make public policy decisions that support economic development;
- developing a competitive advantage and leadership position in the area of economic development;
- developing methods to deliver quality information;
- providing services and certainty to investors;
- helping build a competitive economic infrastructure; and
- helping establish an attractive investment climate on reserve lands.



Curriculum

The program curriculum consists of a series of eight courses focused on providing knowledge and developing skill sets for the facilitation and management of First Nation economic development projects. The program administration ensures that the CFNAE program continues to evolve as new resources, information, and best practices emerge.

REQUIRED COURSES

- Introduction to Basic Economics
- Issues in Aboriginal Economics
- Introduction to University Writing or, Business, Professional and Academic Composition or Composition and Indigenous Literature in Canada
- Residential and Commercial Development on First Nation Lands
- Investment Facilitation on First Nation Lands
- Resource Development on First Nation Lands
- First Nation Fiscal Relationship and Economic Development
- Economic Feasibility and Impact Analysis on First Nation Lands

GRADUATION CRITERIA

To be granted a Certificate in First Nation Applied Economics, participants must successfully complete all required courses, as listed above, with a minimum grade point average of 2.0 (C- average) for each course.

PROGRAM DELIVERY

F2F sessions are normally delivered Monday to Friday, 9 am to 4 pm, and will incorporate lectures, individual and group activities, assignments and quizzes. The courses are normally held on Thompson Rivers University campus in Kamloops, British Columbia, and will encompass a significant amount of reading and self-study, including case studies, lectures and research papers, in conjunction with activities such as group discussions and research. Due to current circumstances, Tulo is currently offering course via virtual learning.

MOODLE

Moodle is a virtual learning system used by the Tulo Centre of Indigenous Economics. We will be using Moodle to post your course material, host presentations, connect through video conferencing, create assignments, facilitate discussions, and more.

Course and Program Requirements

This program has no admission requirements; however, students are required to meet prerequisites of certain courses in the program, as set out below.

In order for students to be successful in the program, the following pre-requisites are required to take certain program courses and to complete the program:

- Completed Provincial Grade 12 Diploma or equivalent.
- C+ or better in Principles of Math 11 or Applications of Math 12, or MATH 051, or equivalent.
- 73% or better on the combined English 12 and Government exam (within the last five years); or Level 4 on the composition section of the LPI (within the last two years); or completion of ENGL 060; or completion of CESL 053, CESL 054 and CESL 057 with a grade of C+ or better.
- Basic computer literary with Microsoft office applications such as Word and Excel spreadsheets.

Computer upgrading can be undertaken by taking COMP 040 and COMP 050 or equivalents. These are highly recommended but not required.

Students who do not meet the above admission requirements can take courses for which they have prerequisites and start the program on a conditional basis while they complete the pre-requisites (i.e. students can take courses that have no prerequisites and at the same time upgrade their required math, English and computer skills).

PROFESSIONAL AND ETHICAL CONDUCT

The Tulo Centre is a community of students, faculty and staff involved in learning, teaching, research and other activities. All members of this community are expected to conduct themselves in a manner that contributes positively to a respectful environment.

Disruptive, disrespectful, discriminatory, harassing or violent conduct is prohibited, including, but not limited to:

- Assaulting, harassing, intimidating, or threatening, directly or indirectly, another individual or a group
- Endangering the health or safety of others

COURSE CANCELLATIONS

The Tulo Centre may cancel courses due to insufficient enrolment or other reasons. If this occurs, participants will be notified and a full refund will be processed (if applicable). The Tulo Centre does not guarantee that a particular course will be offered in a particular term.

WITHDRAWING FROM A COURSE

The Tulo Centre requires a notice of withdrawal from a course at least five business days before the course begins. Notification should be in writing via email (info@tulo.ca) or fax (250-828-9858). Be sure to include student name, course name and start date. Note that withdrawals may result in loss of the FNTC Student Bursary, if applicable, for current and future courses and/or cancellation fees (please refer to the FNTC Student Bursary guidelines).

COURSE ATTENDANCE

The Tulo Centre recognizes the importance of student attendance and participation to succeed in the courses. Due to the nature of the intensive-one-week delivery, 100% attendance is required unless there is an acceptable cause where the student obtains the instructor's authorization for an absence. It is important that students follow all late or absence reporting protocols. As soon as a student determines they are unable to attend a class, they must let their instructor know as soon as possible.
